<u>Public Comment</u> - David Hubler- Landowner- Virtual. Request made by Stepahnie with landowners permission to: request permission to fix damage to the Clark Fork River bank where a violation by his neighbors action of draining a pool had caused minimal erosion to his property. Landowner stated that there was bare ground. **Discussion-** Board requested the landowner to apply for a 310 permit for reseeding and maintenance on the bank.

<u>Administrative-</u> 5th grade Outdoor School- <u>Discussion</u>; Recommendation by Stephanie to move to Earth Day in the Spring, to resource grant funding and have more time to plan, agreed on by all supervisors.

310 Permit

54-28-2022-Meenach, Phil - Remove trees from shoreline-Clark Fork- **Discussion:** No more cutting of trees, and no more trimming of shrubs on the bank of the Clark Fork River. Board requests pictures of regrowth. Motion made by Joe S. seconded by Joe H. to extend the current 310 application 45 days, no site visit on September 20th, application is pending on landowner to send photos of regrowth of vegetation and cottonwood saplings on the bank of the Clark Fork River along the whole property bank front, to include in front of his private residence.

54-26-2022V- Kevin Extreme-Clark Fork River- **Vote for signature.** Motion to approve Jim as representative for the board to sign the "Order of the Mineral County Conservation District" made by Joe S. second by Jim **Vote passes 6-0**

54-29-2022V-Gretchen Webb- Clark Fork River- **Discussion-** Recap of inspection findings Joe H. states the the landowner was not the original builder of the road. Ladd agreed that the road was inherited. Owner stated that the intent for the road is for foot access only and is willing to rehab the lower end by adding aquatic bushes and water bars from top of the road to the bottom. Recommended by Ladd that waterbars be placed every 50 feet, and detailed recommendations were given to the landowner; The landowner is allowed to use equipment, for proper remediation. Details are recorded in the 310 permit. Use of equipment was given to the landowner and replanting of native trees. Due to the cooperation of

the landowner and the 310 application for remediation the board decision: A motion by Jim and second by Joe S. to closed out the Violation with the approved application and issue of permit with a violation fine of \$100.00 to be spent towards the remediation of the road. **Vote Passes 6-0**
